Additional bins for up to 850 residences would be available for \$16.50 per bin. Any residences that are not delivered bins would need to contact the town to get them. Cost for those utilizing the garbage/recycling service will be \$100/year on their tax bill. Anyone who wants to sign up for the service or remove their parcel from service after October 31 will need to contact the town clerk and will receive a billing separate from their tax bill for the next year. Carried

Motion to approve zoning variance for a 24'x32' garage for Dennis Ellie property on Reif Road that is closer to the road than currently allowed by the ordinance by VanDeWalle, second by Wyss. Carried

Motion to approve conditional use permit for Doug Bergeson on Jandt Road for lawnmower racing, corn maze, fall events, craft shows, etc with restrictions of no parking on Jandt Road and no loud noise after 12:00am (midnight) by VanDeWalle, second by Wyss. Carried

Motion by VanDeWalle, second by Wyss to approve all board members to attend WTA Fall workshops and WTA Convention. Carried
